



Application for School Transport Conveyance Allowance

Please read the information on this page before completing the application form.

What is a conveyance allowance?

Caregivers are responsible for transporting students to and from school each day. However, the Ministry may provide assistance where distance may be a barrier for students attending the closest school they can enrol at.

School transport assistance is provided in the form of a **space on a school bus**, and/or **a conveyance allowance**. A conveyance allowance is a payment made directly to a caregiver's nominated bank account to contribute to the cost of transporting a student to school, or in some instances a bus stop. Students may be eligible if:

- there isn't a school bus available, or
- they live more than 2.4km from the nearest school bus route.

Caregivers do not need to complete this form to request a place on a bus. Any queries about children's eligibility to board a school bus should be directed to the bus controller of the child's school.

Who is eligible for school transport assistance?

To be eligible for school transport assistance students must meet all 3 eligibility criteria:

- 1. Be attending the closest school they can enrol at.
- 2. Be living over 3.2km (years 1-8) or 4.8km (years 9+) from the enrolling school.
- 3. Have **no** access to "suitable" public transport (defined on the Ministry website).

Applicants should ensure that they meet each of the above criteria before submitting an application.

How to apply

This form needs to be completed as early as possible for new applications and whenever there is:

- a) a change of address; and/or
- b) a change of school

This form is for one student only. Please fill out additional forms for each student applying for a conveyance allowance.

Which sections of the form should you fill out?

This form has the following sections:

- Section A to be completed by the caregiver
- Section B to be completed by the school
- Section C to be completed by the Ministry

Applications cannot be considered by School Transport until Section A and B of the application have been fully completed, and verified bank details have been provided.

Note: Pre-printed or bank verified account details must be provided in the form of a deposit slip, statement or screenshot from online banking.
